Superintendent Report: Dave Crews reported

- **Reminder**, there is a special board meeting on April 29, 7pm to approve employment for the 25-26 school year and discuss salary changes.
- **Ag Teacher Offer** We have offered Justin Tedford the Ag Teacher to replace Matt Sinclair for next year. He will be on the approval list at the special meeting.
- **Glycol Issue** The water testing results have been better as the glycol has drained/moved through our septic system. We have purchased microbes to help bring the water quality back to normal.
- **Sprinklers** The plan is to turn on the sprinklers next week.
- **School Finance** Under current law, there are 2 total program formulas to finance public schools. Absent the satisfaction of a statutorily specified condition, the first formula is scheduled to stop determining total program after the 2024-25 budget year (expiring formula), and the second formula is scheduled to determine total program beginning in the 2030-31 budget year (new formula). For the 2025-26 budget year through the 2029-30 budget year (transition period), total program is scheduled to be determined by using figures that were calculated under both the expiring formula and the new formula. We will stay tuned for what this all means for our finance dollars for next year. Hopefully we can get some real numbers to put on the revenue side of our draft budget for next year.
- **DAAC Meeting**. The DAAC meeting has been rescheduled for the 22nd of April. We would like to present a draft power point of the possibility of going for a mill levy override.
- **CCIA** We presented to the Colorado Commission of Indian Affairs over Spring Break. We shared the work that has been done to build our relationship with the Jicarilla Apache Nation.
