Academic Achievements:

• The Colorado Department of Education (CDE) determined Sangre De Cristo Re-22J met the conditions for the Body of Evidence condition by (1) submitting a complete Local Assessment Tool that demonstrated local K-2 assessment data resulted in an improved rating, and (2) providing a district narrative that described this data and included a sufficient rationale for participating in the request process. Total points earned with supplemental data is sufficient to earn an Improvement plan type. By meeting these criteria, the CDE recommends the State Board of Education adjust Sangre De Cristo Re-22J's rating from Accredited to Accredited with Distinction.

Financial Management:
