REGULAR BOARD MEETING
June 07, 2022

The regular meeting was called to order at 6:00 p.m. in the Sangre de Cristo School Library, Mosca CO. Superintendent Report: Dave Crews reported:

Thunderbird name change has been put on the list as of May 19, 2022. There is a lot of frustration with this costing the school to proceed with the name change. Mr. Crews is still investigating some other options we may have to retain our Thunderbird name. We may be able to sign an MOU with a tribe to build a relationship with them to better understand their culture. One of the contacts we may reach out to is Fred Bunch from the Sand Dunes. He has contacts with the Ute Indians. We were not granted the BEST Grant. Mr. Crews handed out a plan to cover with the ESSER III Grant, SRS Grant; Insurance will kick in some funds and Capital Reserve. We have now implemented our new Health Plan with CEBT. On July 1, 2022 we will have an increase in PERA for employees and the school.

Approve Appropriation Resolution as read FY 2022-2023: Following discussion Stacey Eskew moved to Approve Appropriation Resolution as read FY 2022-2023. *Be it resolved by the board of education of School District Number Re-22J in Alamosa County that the amounts shown in the following schedule be appropriated to each fund as specified in the "Proposed Budget" for the fiscal year beginning July 1, 2022 and ending June 30, 2023. General Fund \$6,500,000.00; Governmental Designated Purpose Grants Funds (Preschool) \$134,000.00; Pupil Activity Funds \$234,415.00; Food Service Fund \$270,000.00; Capital Reserve Capital Projects Fund \$508,000.00; Bond Redemption Fund \$750,000.00; Scholarship Fund – Fund 72 = \$43,732.00 Total Appropriation = \$8,440,147.00.* Lance Curtis seconded the motion.
