I am in the process of rescheduling.

Superintendent Report: Dave Crews reported:

Geothermal update: Lance, Mark, Gary and Dave (Crews) met to walk around to see all of the boilers. The example of how the boilers are working at this time was compared to running a car at 100 miles per hour all of the time. CSDSIP is working with us to show that it is equipment breakdown and we will need to get it replaced. At present we have CSDSIP and Geothermal talking to each other so we don't have to be the middleman to find a resolution. We are looking to get the vault pressure tested. But have not had very good luck finding someone. We are looking also to see if there is a leak, the found about 8 inches of water. Looking into a portable boiler system should we need it, the cost is 10K to bring it here and the additional cost of hooking it up and the propane. Mr. Crews has started looking into getting a BEST Grant and at best our cost would still be \$400K.

COVID update: Mr. Crews met with the County Health nurse to see where we are with compliance and maintaining a degree of normalcy at the school. Jess Freel brought up the protocol of walking a certain way from class when some of the student's lockers are within two feet of the class and they still need to go around. Neither John nor Dave had heard of any issues but said they would look into it.

Mr. Crews then brought up SB 21-116 regarding the school Mascots. Said that Montrose Elementary school has addressed the Native American counsel regarding the Thunderbird and we are waiting to see the response. As of this time we have not heard anything from the state.
